- The main areas of partnership being explored for the pilot project are using Blockchain in state registers, public services, social security, public health and the energy sector.

- Blockchain technology, among other benefits, will help improve the protection of state databases against unauthorized interference, reduce cost to citizens, improve overall efficiency, improve investment in Ukraine, and help reduce corruption across the board.

head of the State Agency for eGovernance of Ukraine. "We understand that there's no alternative way instead of bringing to public services latest technologies. Blockchain has proved itself as a good ground for cost reduction, government efficiency & transparency to help reduce corruption. All these are among our goals. So we're ready to bring blockchain as part of Ukrainian eGovernment strategy."

"Our partnership with the Ukrainian government is about making the lives of the Ukrainian people better by making systems work for people and reducing friction across the board for all," said Valery Vavilov, CEO of The Bitfury Group. "We are grateful to the forward looking and determined Ukrainian Government for moving in this important direction. The Blockchain is a transformational technology that is easy to use, inexpensive, and much more secure than current systems. This groundbreaking project will continue to advance to include smart-contract capabilities to streamline business operations for NAPR, including the sale of property, transfer of ownership and more, as well as expand to other government departments.
